# BIOLOGY 103 HUMAN BIOLOGY Spring 2013

**Catalog Course Description:** A survey of the structure and normal functions of the human organism and an introduction to human ecology and genetics. This course will not count toward a major or minor in biology. It will, however, count either as a nonlaboratory core science course for nonscience majors or with BIO 104, which will count as a laboratory core science course. Lecture is three hours a week.

**Academic Integrity:** Mississippi College students are expected to be scrupulously honest. Dishonesty, such as cheating or plagiarism, or furnishing false information, including forgery, alteration or misuse of College documents, records or identification, will be regarded as a serious offense subject to severe penalty, including, but not limited to, loss of credit and possible dismissal. ## Required practices:

- 1. The notes for each chapter will be posted on Moodle after the lecture for the entire chapter has been presented. It will be your responsibility to download the conclusion of the chapter. These notes are not all inclusive which means I may add to these during the class. It is very important that you come to class and actively participate in taking notes.
- 2. You will complete two medicine case studies. Each will be worth 40 pts and should be answered in complete sentences and typed. I will assign these at later points in the semester.
- 3. You and other students of the class will be members of a group. Each group will present an ethical issue to the class. You must present both sides of the issue, and your presentation must be objective. Everyone in your group must participate. You will choose these from your textbook. Each chapter has a Bioethical focus. Make sure you answer each question listed in the section. Refer to the section on "Looking at Both Sides" for more details. There is no written component. Your grade is based on your ability to present both sides of an issue objectively. **Do not just state your opinion.** This project is worth 40 points.
- 4.Exams
  - a. Four lecture tests will be given during the semester. The tentative Test dates are listed below; however these are not rigid and may necessitate being moving back a class period due to pace of progress. The format of the exams may include: multiple choice, matching, fill-in-the-blank, true/false, short answer, or discussion. There are no make-up exams. Please see the section "Absence from an exam" for a more detailed explanation about absence from an exam.
  - b. The **Final Exam** is a **comprehensive** final. It is worth 200 points.
- 5.Quizzes will be given throughout the semester every Wednesday. They will cover material that has already been covered in lecture. They will total 30 points, and I will drop your lowest quiz grade.
- 6.I reserve the right to add other assignments during the semester.

### Absence from class:

It is your responsibility to obtain missed notes / assignments from another student if you miss a lecture. If you are absent from class and have a classmate sign you in as present I take this as a lack of integrity and nearly tantamount to cheating. First time offense will result in loss of all drop quizzes. Second time offense will result in loss of 10 points from next exam. Third and subsequent offenses will be arbitrated by instructor in a manner reasonable and prudent to the infraction. Penalties will apply to both the student who signed in another student and the student(s) who was (were) signed in.

### Absence from a quiz:

Students will not be allowed to make up quizzes, even for excused absences. Quizzes will not be given early, even earlier on the same day. One must be present in class at their assigned meeting time in order to take a quiz. A missed quiz may count as one of your drop quizzes, of which you are allowed three.

#### Absence from an exam:

You know when exams are scheduled. A zero will be recorded for missed exams. When you have to miss an exam due to official school business, alerting me to this situation and arrangements to make up an exam must be made with me beforehand. In order to take the make up exam the student must bring a note from the coach/sponsor of the team/group that caused you to be absent on exam day explaining why the student was absent. Excused absences from exams include serious illness and certain emergencies. A note from a physician/coach/sponsor must be given to the instructor with-in 72 hours of missing an exam for an absence from an exam to deemed as acceptable to make up. Also, should you be seriously ill or have a grave emergency that precludes you from sitting for the exam, an email to me within 24 hours of the exam stating the nature of your absence is necessary in order to take the exam. Having another exam on the same day of a BIO 103 exam is not an extenuating circumstance or an excuse for missing an exam. Upon determination that a student is eligible to make up on exam, the make up exam will be offered only once at Monday 4:30 pm of the week following the exam. No further make up exams will be offered past this date. The final exam may not be made up.

# Class etiquette:

This is our class and it belongs to each one of us. Arriving late, texting, receiving cell phone calls or pages, or being disruptive robs us of the time that we have to work together. These behaviors will not be tolerated. A student may be asked to leave class if found to be partaking in any of the aforementioned behaviors. After 5 minutes of class has passed I will lock and close the door. It will not be opened for tardy students.

#### Attendance

This only applies to seniors who are graduating in May!.

# Regarding Disabilities:

If you are a student who needs special accommodations due to learning, physical, physiological, or other disabilities, please contact Dr. Morgan Bryant, Director, Student Counseling Services. In order for a student to receive disability accommodations under Section 504 of the Americans with Disabilities Act, he or she must schedule an individual meeting with the Director of Student Counseling Services immediately upon recognition of their disability (if their disability is known they must come in before the semester begins or make an appointment immediately upon receipt of their syllabi for the new semester). The student must bring with them written documentation from a medical physician and/or licensed clinician that verifies their disability. If the student has received prior accommodations, they must bring written documentation of those accommodations (example Individualized Education Plan from the school system). Documentation must be current (within 3 years). The student must meet with SCS face-to face and also attend two (2) additional follow up meetings (one mid semester before or after midterm examinations and the last one at the end of the semester). Please note that the student may also schedule additional meetings as needed for support through SCS as they work with their professor throughout the semester. Note: Students must come in each semester to complete their Individualized Accommodation Plan (example: MC student completes fall semester IAP plan and even if student is a continuing student for the spring semester they must come in again to complete their spring semester IAP plan).
