## Programmatic Changes

- Comprehensive Program Evaluation Plan: modified February 2024; launched August 2024 <u>G:\Program Assessment\ComprehensiveProgramEval.plan.docx</u>
- CPCE Policy: students now have two opportunities to pass their exam at a 55% pass rate. If students do not pass after two attempts, graduation is delayed for a full semester & student must complete the Counseling Portfolio Demonstrating Competence. Students completing the portfolio must earn a passing score on each core area that did not meet the 55% pass rate on their most recent CPCE score report.<u>G:\Curriculum Changes\Spring 2024\CPCE</u>

- COU6503/Helping Relationships: the prerequisites for this course were removed & the course was moved up in the course sequence such that students complete the course in their first or second semester in the program. The intent is to catch problems of professional competence earlier so that remediation can be offered to students. Additionally, if program dismissal occurs related to counseling skills & disposition, students will not have invested more than two semesters in the program.
- Summer admission is no longer available. In the summer semesters, we got a very low number of new students & scheduling became difficult due to having to offer the core courses each semester we accept new students. In addition, often courses would close & students would have to select other options which often lead to them taking courses out of sequence.

The Department of Counseling at Mississippi College continues to be mindful of our program mission, objectives, and CACREP standards such that our graduates are competent clinicians who are prepared to serve our communities.
