Started in August 2020, my YouTube series is designed for those who seek the promises of the Preamble of the Constitution to establish more Justice in our society. This series provides: (1) a taste of justice with learning about the Constitution for the broader community; (2) for law students enrolled in my in-person and in my remote classes, opportunities for supplemental engagement on the topics we are covering; (3) for those thinking about attending law school or who just want to learn more about the law during these times, insights to better discuss (debate) and build with others.

I seek to help my students take a soak in the law, and not just a quick shower in the law, and to bring all my viewers a Taste of Justice by sharing a little taste of Constitutional Law and a little taste from my other course Civil Rights Lawsuits (42 U.S.C. sec. 1983) (courses I taught fall 2020).
