

Senate Minutes
November 30, 2015

- The regular weekly meeting of the Mississippi College Student Senate was held Monday, November 30, 2015 at 9:15 p.m. Student Senate President St John presided over the meeting and Senate Clerk Waller was present. Invocation was given by Senator Stevens. Pledges were given by Senator Richardson. Senators Meek and McDonald were absent and Senators Price, W. Taylor, and J. Richardson were tardy. The minutes were approved as corrected. Motion to previous question was given by Senator Stringer.
- Senate Resolution 2015-16-13, asking that the limit of students of the opposite gender that can be checked into a residence hall be increased to five, was presented by Senator J. Richardson. Motion to skip debate and roll call vote was given by Senator Kerstell. By a roll call vote of 34-1-4 Senate Resolution 2015-16-13 passed.
- Senate Resolution 2015-16-14, asking that two speed bumps be installed in the parking lot of University Place, was presented by Senator West. Motion to open floor for debate was given by Senator West. Senators Hutto and C. Stevens spoke in affirmation and Senator Ainsworth spoke in negation. By a roll call vote of 35-3-1 Senate Resolution 2015-16-14 passed.
- Senate Resolution 2015-16-15, asking that a speed limit sign be placed at every entrance to campus, was presented by Senator Ellis. Motion to skip debate and voice vote was given by Senator West. The aye's had it, and Senate Resolution 2015-16-15 passed.
- Senate Resolution 2015-16-16, asking that during an emergency, Mississippi College sends out a campus wide e-mail with a link to the page of the Office of Public Safety, was presented by Senators Stringer and James. Motion to table the bill for Committee review was given by Senator C. Stevens.
- The following changes to the Constitution were presented and voted on by Senators:
–Article III Sections 1-6: Passed: 39-0-0
- The following changes to the By-Laws were presented and voted on by Senators:
–Title V Section 104: Passed: Vote
- Senate Resolution 2015-16-17 was presented by Senator Castle. Motion to table the bill for Committee Review was given by Senator Ainsworth.
- Senate, by motion of adjournment given by Senator West adjourned at 9:51 p.m.
