## Senate Resolution 2015-16-19

- •Whereas, the University has established recommended procedures to be followed during emergency situations on campus;

- •Whereas, every month, the MC Alert system is tested through email and text message;
- •Be it resolved, a link to the recommended procedures be added to the MC Alert test messages that are sent on the first of every month.
- •Be it further resolved, a comprehensive email outlining all of these recommended procedures be emailed to students within the first week of each academic semester.

## Senate Resolution 2015-16-20

- •Whereas, final exams are an intense period of stress and worry for students;
- •Whereas, students do not need the undue stress of receiving a parking citation during final exams;
- •Whereas, many students wish to park freely on campus for long days of studying during final exams:
- •Be it resolved, that Mississippi College allow open parking in all R1, R2, R3, and Commuter lots beginning at 6:00 pm the Wednesday evening preceding study day through the completion of final exams.

## Senate Resolution 2015-16-21

- •Whereas, there is currently not a crosswalk on the north side of the intersection of Clinton Parkway and Fairmont Street;
- •Whereas, students who live in University Place and utilize the Baptist Healthplex often cross this busy intersection;
- •Whereas, without an actual crosswalk painted on the road surface, cars traveling down Clinton Parkway may not be as cautious when traveling in the area;
- •Be it resolved, Mississippi College administration work with the City of Clinton to install a crosswalk on the north side of the intersection of Clinton Parkway and Fairmont Street.
