OFFICIAL MINUTES
February 27, 2017

- The regular weekly meeting of the Mississippi College Student Senate was held Monday, February 27, 2017, at 9:15 p.m. Student Senate President West presided over the meeting and Senate Clerk McRae was present. Invocation was given by Senator Channell. Pledges were given by Senator Melancon. Senators Brown, Dutra, Lee, Parker, Spears, and Williams were absent. Senators Castle and Rodriguez were counted tardy. The minutes were approved as corrected. Motion to previous question was given by Senator Denley.
- Senate Resolution 2016-17-20 regarding installation of a utensil dispenser in the library coffee shop was reiterated by Senator K. Collins. Motion to skip debate and voice vote was given by Senator Hicks. The ayes had it and Senate Resolution 2016-17-20 passed.
- Senate Resolution 2016-17-21 regarding installation of an ATM on campus was reiterated by Senator Powell. Motion to skip debate and voice vote was given by Senator Denley. The ayes had it and Senate Resolution 2016-17-21 passed.
- Senate Resolution 2016-17-22 regarding a restructured email system for campus announcements was reiterated by Senator Shamblin. Motion to skip debate and voice vote was given by Senator Hicks. The ayes had it and Senate Resolution 2016-17-22 passed.
- Senate Resolution 2016-17-23 regarding the installation of a sidewalk outside the Student Life Center was reiterated by Senators Green and Chandler. Motion to open the floor to debate was given by Senator Channell. Senators Stringer and Gaddy spoke in affirmation, and Senators Lagarde, G. Smith and Santos spoke in negation. The motion to roll call vote was made by Senator Channell. Senate Resolution 2016-17-23 did not pass with a vote of 16-20-1.
- Senate Resolution 2016-17-24 regarding the repaving of the College Street entrance was reiterated by Senator Hicks. The motion to open the floor to debate was made by Senator Stringer. Senators G. Smith and Hicks spoke in affirmation, and Senators Ladner and K. Smith spoke in negation. Motion to roll call vote was made by Senator Hicks. Senate Resolution 2016-17-24 passed with a vote of 24-13-1.
- Senate Resolution 2016-17-25 regarding free water cups in 1826 was reiterated by Senator Jenkins and M. Collins. Motion to skip debate and voice vote was given by Senator Denley. The ayes had it and Senate Resolution 2016-17-25 passed.
- Three applications for the Campus Improvement Fund were presented: repairs to the Alumni Gym floor by Senator Nash, a new mock trial room by Senator Foster, and the installation of tennis court platforms by Secretary McRae. The motion to open the floor to debate was made by Senator Rodriguez. Senators M. Collins, Pike, Stringer, Ladner, K. Smith, K. Collins, Lagarde, B. Richardson, Baker, and Denley all spoke in affirmation of at least one of the presented improvements. Motion to roll call vote was made by Senator Denley. The repairs to the Alumni gym floor received the most votes with 23 votes, then the mock trial room with 11 votes, and finally the tennis court platforms with 4 votes.
- Student Senate President West announced the Executive Council Interest Meeting for Wednesday, March 3, as well as the SAAC parking lot volunteer opportunity. CAB Chairperson Slattery announced a CAB event for Tuesday night. Senator Rodriguez announced the Jazz Band concert coming up.
- Senate, by motion of adjournment given by Senator Hicks, adjourned at 10:29 p.m.
