- The regular weekly meeting of the Mississippi College Student Senate was held Monday, April 15, 2016 at 9:15 p.m. Student Senate President West presided over the meeting and Senate Clerk McRae was present. Invocation was given by Senator Stevens. Pledges were given by Senator B. Richardson. Senators McCoy, Raynor, Meek, W. Taylor, Melancon, Smith, S. Stevens, Ellis, McDonald, and L. Williams were absent and Senators Hutto, Parish, Price, Kerstell, McGehee and Parker were tardy. The minutes were approved as corrected. Motion to previous question was given by Senator Stringer.
- Class officers presented their end of the year reports.
- Changes to the Bylaws Title IV: Section 102 and Section 106, were presented by the Documents and Protocol Committee. Motion to skip debate and voice vote was presented by Senator Stringer. The ayes had it, and the amendments passed.
- Senate Resolution 2015-16-32, asking that dead days and exam schedule be redefined in the Academic Catalog, was presented by Senator Stringer. Motion to move to emergency vote was given by Senator Ainsworth. Motion to skip debate and voice vote was given by Senator Castle. The ayes had it, and Senate Resolution 2015-16-32 passed.
- Senate Resolution 2015-16-33, asking that a business course added as a requirement for graduation, was presented by Senator Waller. Motion to move to emergency vote was given by Senator Castle. Motion to move to debate was given by Senator C. Stevens. Senators C. Stevens, Taylor and Castle spoke in affirmation. Senators Terry, Richardson and Anderson spoke in negation. Motion to voice vote was given by Senator Channell, and Senate Resolution 2015-16-33 passed 16-11-0.
- Senate Resolution 2015-16-34, asking that fans be added to library study rooms, was presented by Senator M. Collins. Motion to move to emergency vote was given by Senator Rodriguez. Motion to skip debate and voice vote was given by Senator C. Stevens. The ayes had it, and Senate Resolution 2015-16-34 passed.
- Senate Resolution 2015-16-35, asking that the sun decks on the roof of East and West residence halls be repaired, was presented by Senator M. Collins. Motion to move to emergency vote was given by Senator Ainsworth. Motion to skip debate and voice vote was given by Senator Hicks. The ayes had it, and Senate Resolution 2015-16-35 passed.
- President St. John announced the deadline of the SGA Scholarship Application. Outgoing President Mary McRae reminded Senators to remember International Senator Zeng as she went home to China.
